Dear Members.

We have emphasized on numerous occasions that the Polish & Slavic Federal Credit Union has a dual mission to fulfill. First and foremost, we are



a reliable financial institution with a wide range of modern financial services for our members. The second part of our mission is to help and support the Polish community in the United States. We accomplish this second part of our mission in many different ways. Firstly, we support our sponsoring organizations, of which there are 10, through the annual collection of our membership dues. This year we have provided over \$1.38 million in membership dues. For some of our sponsoring organizations, it is their main source of funds, allowing for their continued social activities within the Polish-American community. I am glad that we can provide assistance in collecting the dues, but at the same time I would like to thank you for your generosity and reliability, as this is your money allocated to support the above organizations.

As a Credit Union, last year we set aside nearly \$600,000 earmarked for donations, which benefited 116 organizations, parishes and Polish schools. Scholarships for young students are a significant item in our budget for supporting the Polish-American community. In 2022, \$551,000 in scholarships was distributed to 488 students. On various occasions, we also support Polish Supplementary school children, as exemplified by the number of 2,046 monetary certificates for a total amount of more than \$120,185 given as prizes and awards to young students.

The Polish & Slavic Federal Credit Union plays a special role in sponsoring Polish-American media. In the previous year, we allocated over \$560,000 to support the Polish press, television and radio in the United States, and we are by far the largest advertiser in the Polish-American market. Throughout the year, our institution in various forms was involved and present at 345 Polish-American events. Many of these events were not only sponsored, but also initiated by us. I also can't help but mention our initiatives related to the now traditional Children's Holiday Smsmile fundraiser for children's hospices in Poland. In 2022, thanks to your generosity, we donated more than \$127,000 to the needs of sick children. In March 2022, we reacted very quickly to the tragic events in Ukraine and initiated a fundraiser to help Ukrainian refugees in Poland. As a result, you donated more than \$260,000 thousand for this purpose, and our Credit Union added another \$100.000.

The above examples reflect how much we are involved in the success of our mission to support the Polish-American community, as well as how crucial our institution is in this respect. I would like to assure you that the current Board of Directors and Management fully understand the needs of the Polish-American community and are in favor of broad, but also - in accordance with our mission - responsible support for its needs.

In conclusion, I encourage you to use our products and services, as in this way you also support Polonia. At the same time, I would like to encourage you to be actively engaged in the affairs of our ethnic group, as together we can build a strong Polish community in the United States.

A formal celebration of Casimir Pulaski Day took place on March 6th, 2023 at the Polish Museum of America at 984 N. Milwaukee Avenue in Chicago. Traditionally, Polish & Slavic Federal Credit Union was a sponsor of this honorable event.

The Pulaski Day celebrations included speeches, artistic performances, and the unveiling of the Polish Heritage Corridor, a stretch of Milwaukee Avenue that runs all the way from Chicago West Town to Niles. Flowers were also laid under the symbolic painting by Stanisław Kaczor Batowski titled "Battle of Savannah".

Board of Directors, Franciszek Piwowarczyk. With great passion he proudly highlighted the achievements of the Polish hero of American Revolutionary War. Franciszek Piwowarczyk also emphasized the importance of the role of the Polish-American community, both in the past and present.

Among the guests of honor were numerous representatives of both international and local authorities: Congressman Mike Quigley, State Senator Robert Martwick from District 10, Illinois State Treasurer Michael Frerichs, as well as the Consul General of the Republic of Poland in Chicago Paweł Zyzak and the Consul General of Ukraine, Serhy Koledov.

Every year, the Polish community in Chicago pays tribute to the hero of two nations. According to the June 1977 state legislation, the first Monday in March is a state holiday honoring Gen. Pulaski. Cultivating the memory of General Casimir Pulaski is an integral part of the national heritage of the Polish community in the U.S., passed down from generation to generation. On behalf of the organizers of General Casimir Pulaski Day celebrations in Chicago, the Polish & Slavic Federal Credit Union would like to thank everyone for their participation and involvement in the highly dignified celebrations and the organization of meetings, lectures and curriculums in Illinois's institutions and schools. Consular duty in branches of the Polish & Slavic Federal Credit Union in Illinois

In reponse to the needs of the Polish community in the Chicago consular district, the Consulate General of the Republic of Poland in Chicago is launching additional passport application and legal document submission points at our Credit Union's branches in Illinois.

Beginning on April 12, 2023, passport applications and applications in legal matters (registration of marriages, births, change of name and last name, certification of signature and copies) can be submitted during consular duty hours at the branches of the Polish & Slavic Federal Credit Union in Chicago.

The introduction of consular duty

hours in branches of our Credit Union is aimed at facilitating the submission of passport applications and other consular documents for PSFCU members, the elderly, and disabled individuals who may have difficulty with accessing the Consulate General of the Republic of Poland in Chicago.

Passport visits at PSFCU branches can be arranged free of charge using the E-KONSULAT electronic registration system. Registration instructions and details on how to prepare for the visit can be found on the Consulate General's web page page within the www.gov.pl portal.
