Annual Meeting of the Polish & Slavic Federal Credit Union



The Annual Meeting of the Polish & Slavic Federal Credit Union was held at the Polish Museum of America in Chicago on Saturday, May 20, 2023. During the meeting, PSFCU members were informed about the results of our Credit Union's operations in the fiscal 2022 and asked questions on the matters related to the PSFCU. During fiscal 2022, PSFCU assets reached \$2.54 billion, deposits grew to \$2.44 billion, and the total loans granted increased to a total of \$1.47 billion. As a result of our operations, the net income reached \$14.37 million. 9,492 new PSFCU members opened their accounts during fiscal 2022.

During the meeting, the names of the directors were announced who will serve on the Board of Directors in 2023-26. In the 2023 election, the following people ran for the PSFCU Board of Directors: Ryszard Bak, Malgorzata Gradzki, Karol Kwiatkowski, and Leszek Wojtkowski.

May 3 Constitution Day Parade in Chicago

The 132nd May 3rd Constitution Day Parade was held on May 6 in Chicago and was attended by Poles and representatives of the American government and military. The event was held under the motto "Polish-American partnership for peace", and the guest of honor was the Deputy Prime Minister and Minister of National Defense Mariusz Błaszczak. The head of the National Security Bureau, Jacek Siewiera, read a letter from the President of Poland, Andrzej Duda, and the First Lady of Poland. The parade was attended by over a hundred Polish organizations, schools, and parishes, including the well-received presence of our credit union.

The main criteria for finding the right credit card are low interest rates and no annual fees. Good news! Our credit cards meet these conditions and guarantee many additional benefits. PSFCU offers credit cards for people who use them often and for those who use them only occasionally. If you are in the first category, a person who uses credit cards often, you will want a card that offers rewards points. If you are not interested in earning points but use a credit card occasionally, you will likely be interested in a credit card with the lowest interest rate.

The next category of credit card users are individuals who travel around the world. Visa Elite Signature credit card offers no fees for foreign transactions, an accident and baggage delay insurance program, free car rental insurance, travel services, and emergency assistance. In addition, the PSF-CU Visa Elite Signature Credit Card gives you the opportunity to earn rewards points. When using the Visa Elite Signature Card, for every dollar spent, the cardholder receives 1.25rewards points. Earned points can be redeemed for cash, which, depending on one's decision, can be used towards paying off the credit card's balance or deposited directly into your PSFCU account. Elite Signature card holders can also redeem their points for various products and travel services, as well as earn 5,000 points while spending \$1,500 in the first three months. Points redeemable for products or gift cards are also earned on Premier card. This card has a car rental insurance program.

Opening a term share certificate with our credit union is the best way to ensure future financial security. During the month of June, we are offering our members a promotional interest rate for term share certificates!

The promotional interest rate on term share deposits varies depending on the amounts deposited and is as follows:

- \$500 to \$49,999.99 3.00% APY*,
- \$50,000 to \$89,999.99 3.50% APY*;
- \$90,000 and above 4.00% APY*; 30-month term share certificates:

However, sometimes you might need this money to buy a new home. Having in mind those members who plan to purchase real estate soon and at the same time want to invest funds in a term share, we are offering favorable conditions for term share termination. We will charge no fees if you apply for a mortgage loan at our Credit Union.

This offer applies to closed term share certificates on the condition that the balance of term share is used by eligible PSFCU members to cover their down payment for the purchase of real estate financed by a mortgage loan obtained from PSFCU.
