Dear PSFCU Members,



One of the main tasks of the PSFCU Board of Directors is to determine the long-term development strategy of our institution. January is the month in which we approve the previously discussed three-year Strategic Plan of PSFCU, as well as the budget and business plan of PSFCU for 2024. I am very pleased to tell you that the strategy of stable but continuous development of PSFCU in the coming years will not change. The growth of the Credit Union is primarily associated with the increase in the number of our members. We will strive to achieve it not only by expanding the geographical footprint of our operations, but also by constantly ensuring the highest possible level of products and services offered. As part of these initiatives, in the coming months we will launch our representative office in Warsaw, which is to serve an increasing number of our members deciding to return to Poland. We are also constantly looking for suitable locations for new branches in Polish communities in the United States, although this is an increasingly difficult task due to the demographic changes taking place among the Polish-American community. At the beginning of the fourth quar-

ter of 2024, we plan to introduce a modern mobile and online banking platform - a project that, for objective reasons, we were unable to implement last year. PSFCU Management pays particular attention to cybersecurity, which is reflected in the significant amounts allocated for this purpose in this year's budget. These are just some of the numbers of strategic initiatives that we intend to implement this year. Taking care of the very good financial condition of our institution, we are also able to implement multi-level missions of supporting the Polish community in the United States. I am very glad that the Credit Union budget for this year includes the same, and in some categories increased, amounts to support the communities in which we operate. We

are the only institution in the United States that allocates approximately \$2 million annually to Polish education, culture, cultivating Polish traditions and supporting Polish media. We should all be proud of this fact as Credit Union members.

Finally, I invite you to use our services as widely as possible, because it is thanks to your commitment and reliability that the Polish & Slavic Federal Credit Union can implement its mission and plans for the future with great success.

Another successful Children's Holiday Smile campaign is behind us. Thanks to your commitment and generosity, between November 24, 2023 and the end of that year, we collectively raised \$150,173.

For ten years, the Children's Holiday Smile campaign has helped 25 hospices in Poland, a hospice in Vilnius, Lithuania and the Children's Smile Foundation in New York, which allocates funds to help seriously ill Polish children. Anyone who has ever seen suffering and pain in a child's eyes engages in charity campaigns without hesitation. Hospices are very im-

portant places, full of great sadness and grief, and yet awakening the need for help and helping to look at the world from a slightly different perspective. Palliative care includes not only alleviating pain and other ailments, but also the patient's social and spiritual problems. Small patients in hospices receive care, understanding and love. The centers also provide assistance to their families and loved ones.

In the course of this edition of Children's Holiday Smile, you helped three hospices and the Children's Smile Foundation.

Alma Spei Hospice for Children in Krakow provides palliative and hospice care to children from the Lesser Poland province in their family homes since 2008. Alma Spei accompanies families from the moment the child is diagnosed with an incurable disease, in their daily struggle with the disease, through the moment of death, to the period of mourning after the loss of the child. So far, over 250 children have benefited from hospice care.

The **BETANIA Hospice and Care Center in Przemysl** is currently the largest project of the Knights and Hospital Order of St. Lazarus from Jerusalem in Poland. Adapting an empty hospital building, they will create an in-patient hospice and a 60-bed care and treatment facility, a home hospice, a perinatal hospice and a medical rehabilitation service center. The center will provide help and care for chron-

ically and terminally ill people. So far, over seventy percent of the investment has been completed.

Via Spei Hospice in Tarnów - i.e. The Way of Hope is a house created for people suffering from terminal cancer. The construction of the hospice took 12 years. The dedication and official opening ceremony took place on January 15, 2024. A modern hospice serves as a comprehensive care center for terminally ill people, also available free of charge to the poorest and lonely people.

Children’s Smile Foundation, New York, founded in 1999, helps children in need in Poland and the United States. The foundation gains funds to help those under its care thanks to the support of sponsors. The campaign organized by the Foundation and the Polish & Slavic Federal Credit Union - i.e. „Children’s Holiday Smile” - has the greatest response from donors.

We would like to thank you for ev-

ery dollar you donate to the Children’s Holiday Smile campaign. We would also like to thank you for your involvement and promotion of the campaign in your communities, parishes, schools and organizations. Without your good will and generosity, such a spectacular ending to this year’s campaign would not take place. The donations you make are a great help for the above hospices and their patients. Protect Your Personal Data

The number of people who become victims of fraudsters grows every year. Cybercriminals are developing newer methods of eliciting logins, passwords and personal information. Can you protect yourself against it? Yes, by being careful and keeping your data safe. First of all, stay up to date, read about fraudsters' methods and the ways of protecting confidential information.

Artificial intelligence is increasingly being used for fraud, and while it makes a huge contribution to beneficial projects, unfortunately cybercriminals also take advantage of its potential. How can artificial intelligence

be used for fraud? For example, it can generate convincing emails, messages, fake audio or video content by manipulating existing recordings or images. Using such recordings, fraudsters send requests for funds or confidential information. Voice synthesis in phone calls allows them to create automated human-like calls. In this way, they impersonate trusted government agencies or financial institutions in order to persuade individuals to provide confidential information or make transactions. Fraudsters know many tricks that can fool you. Analyze, think and be assertive. Don't be deceived and taken ad-

vantage of.

An important form of strengthening data protection is its constant control and updating. To avoid unnecessary stress, verify the information on your bank accounts. This is essential for safety. Whether you've moved, changed your phone number or updated your email address, make sure we have your accurate information.
