The first weekend of March in Chicago passed in accordance with the tradition associated with the 279th anniversary of the birth of Casimir Pulaski, father of the U.S. Cavalry. Pulaski Day was established as a state holiday in Illinois in 1977. For decades, successive generations have honored the hero of the struggle for the freedom of two nations and paid tribute to the entire Polish community.

Representatives of state, city and county authorities, as well as politicians, clergy and Polish organizations took part in Pulaski Day celebrations organized by the Polish American Foundation in Illinois and the Polish American Congress for Illinois. The ceremony was held on Sunday, March 3, at

the Mayfield banquet halls. In the gardens of the headquarters of the Polish Highlanders Association of North America, a solemn ceremony was held at the bust of Casimir Pulaski on Saturday, March 2. The Polish Museum in America celebrated Pulaski Dav on Monday, March 4.

Casimir Pulaski is one of only eight people in the history of the United States to have received honorary U.S. citizenship. Pulaski Day is extremely important for the Polish community living in the United States. Our Credit Union emphasizes its presence and involvement in the celebration of great Pole. The legacy he left behind fills us with honor and pride in the white and red colors.

## National Day of Remembrance of the Cursed Soldiers

National Day of Remembrance of the Cursed Soldiers was established in 2011 to preserve the memory of partisans who did not lay down their arms after World War II and continued the fight against the Soviet occupier. Between 120,000 and 180,000 Poles fought in the anti-communist underground between 1944 and 1963, and March 1 is a national holiday devoted to their memory.

On March 3, the Shrine of Our Lady of Czestochowa in Doylestown, PA hosted a solemn celebration of the National Day of Remembrance of the Veteran Soldiers organized by the Smolensk-Katyn Committee and the Polish Army Veterans Associ-

ation of America, District 10. The Polish & Slavic Federal Credit Union was represented by the manager of the PSFCU branch in Trenton, NJ, Barbara Milewski. The ceremony began with a prayer and an Remembrance roll call. After the laying of wreaths at the Monument to the Cursed Soldiers, a solemn Mass was celebrated.

Also on Sunday, March 3,

Polonia walked the trail in New York's Forest Park to commemorate the memory of the Cursed Soldiers. The "Wolf's Trail" run is an event organized by the Pilsudski Institute since 2016. More than 150 people took part in the seventh edition of the run, including students of Polish schools, scouts, representatives of various organizations and businesses. In accordance with tradition, adult participants ran 1963 meters, while the voungest children ran a trail of 500 meters. As the Institute's president Iwona Korga stressed, "The Wolf's Trail' Run commemorates extraordinary people, who for many years could not even be mentioned in conversations.



# Avoid Spoofed Phone Calls

We would like to remind you to never provide your personal financial information, such as your credit or debit card number, card CVV number and expiration date to individuals contacting you unexpectedly. Our representatives will not ask for this type of information to verify your identity. Even though a message or call does not originate from PSFCU, Caller ID may often show spoofed telephone number of our branch or Member Services Center. Regrettably, PSFCU has no control over this since our phone number is public information. Thus, a fraudulent call may appear on the phone screen or Caller ID device as originating from our Credit Union. Even if you're being called from a spoofed number, this by itself does not mean that your information was compromised. On the contrary, the caller asks additional questions in order to obtain sensitive personal information directly from you.

If you receive such a call or have any doubts about the authenticity of the caller, please hang up and call our Member Services Center back at 1.855. PSFCU.4U (1.855.773.2848).
