We are now at the start of a special period - Christmas and the beginning of the New Year. For many of us it is a period of reflection, thought-



fulness, taking stock and setting new goals for the future. The passing year was a year of stable and sustainable growth for the Polish & Slavic Federal Credit Union. And while there will still be time for a financial summary of the passing 12 months, I can already say that this year we have managed to meet most of the stipulations of our Credit Union's strategic plan, which includes, first and foremost, an increase in the number of PSFCU members, of whom there are already more than 122,000.

As part of the implementation of the Polish & Slavic Federal Credit Union's strategy, one of the main pillars of which is the continuous development and modernization of technological infrastructure, I am pleased to announce that a new, updated version of PSFCU's electronic banking was launched in early November of 2024. The mobile and online platforms were designed with the changing needs of our Credit Union's members in mind, as well as their comfort and security. I believe that the modern design, intuitive user experience, as well as

the new e-banking features will meet your expectations, making everyday financial management easier.

I am also pleased to announce that during the October Board of Directors meeting, held for the first time ever in Chicago, the decision was made to open a new 24th branch of our Credit Union. It will be located in Bolingbrook, IL and will be our 8th branch in the Chicago metropolitan area. We anticipate opening this branch in

the 2nd quarter of 2025.

The approaching Christmas is a time when we extend a helping hand in a special way to those who need it most. For the 11th time, our Credit Union, together with the Children's Smile Foundation in New York, organizes the "Children's Holiday Smile" fundraising drive, aimed at providing support and financial assistance to terminally ill children under hospice care in Po-...continued on page 2

### 2024 Children's Holiday Smile

We cordially invite all members of the Polish & Slavic Federal Credit Union to take part in the "Children's Holiday Smile" charity event, organized for the eleventh time. The charity fundraiser is organized jointly with the New York-based Children's Smile Foundation, and the funds raised in this year's edition will be donated to help children in children's hospices in Poland and those in charge of the Children's Smile Foundation.

This year's campaign will begin on November 29 and will run until December 31. The beneficiaries of the collection will traditionally include three hospices for children in Poland and the Children's Smile Foundation in New York.

The aim of our campaign is to help underprivileged children in both Poland and the United States, and the period around Christmas is the perfect time to do so. During this time we are more eager to help the weak, sick and suffering. That's why we're happy that we've been able to support kids for 11 years now, and we believe that our actions will bring smiles to their faces. We very strongly encourage all of you to join this noble initiative this year as well. Over the course of this decade, thanks to the kindness and generosity of PSFCU members, nearly \$1.3 million has been raised, for which we thank you very much.

Special accounts have been established at PSFCU for the aforementioned organizations, from which, after the fundraiser is completed - without any fees or deductions - all the collected funds will be transferred to the respective beneficiaries. Donations with the designation of the chosen hospice or foundation in New York can be made in two ways:

- 1) by wire transfer in PSFCU's online or mobile banking, typing CSF in the name field, then the corresponding account number of the organization of your choice and "05" in the "Share ID" field;

Let's keep helping, because it's worth it!




### Scholarship Program for High School Graduates Is In Progress
