Dear PSFCU members...

Summing up the 2024 calendar year, I am pleased to note that it was another year of dynamic growth for our institution. During the



year, we recorded growth in both assets and deposits, as well as in the loan portfolio of the Polish & Slavic Federal Credit Union. In particular, we are very pleased with the increasing number of people using our services. In 2024, approximately 11,000 new members opened an account at our Credit Union, and the total number of PSFCU members increased to 122,723. As a result of our operations, our Credit Union's net profit for 2024 amounted to nearly \$18.5 million, the second highest in the history of our institution.

At the same time, we also made many capital expenditures. In early May, we officially opened the PSFCU Representative Office in Warsaw. Its task is to help serve the nearly 15,000 PSFCU members currently living in Poland. In June, we officially opened the 23rd branch of our Credit Union, located in New Britain, CT. It was established through the transformation of the PSFCU Mortgage Loan Office which had operated there previously. Last October, the Board of Directors approved the plan to establish the 24th branch of our

Credit Union in Bolingbrook, IL. It will be our eighth branch in that state; renovations are currently underway and we have scheduled the opening of the branch for the second quarter of this year.

In 2024, we also made considerable investments in the technological development of our institution. In November, we launched an upgraded and unified online and mobile banking application. In addition to greater ease of use, this application places special emphasis on the security of your accounts and the transactions you perform. We will continue technological development in the current year, including adding extra features to the new application, including Zelle.

PSFCU's stable financial position enabled us to continue our support for the Polish community at an even higher level last year. Through our marketing budget, we assigned nearly \$2.8 million to sponsoring Polish events and media. In addition, we provided nearly \$600,000 in donations to a number of

community organizations, Polish parishes and Polish schools, and another \$600,000 went to the PSFCU Scholarship Program, which benefited nearly 600 students.

Our successes and the trust that PSFCU members place in us motivates us - PSFCU employees - to work even harder and create more ambitious plans for the future. Geographic expansion and the continued acquisition of new PSFCU members, while ensuring the excellent financial condition of the institution is our strategic priority for this year and future years.

Thank you for your past commitment and trust, as well as continued use of our products and services, which have undoubtedly been the basis of our successes in the past and which we hope to continue in the coming years as well.

season, which has lasted for more than a decade, has become a permanent fixture in our Credit Union's calendar, and thanks to your generosity, it is an annual success and a great pride for the Polish community and our institution.

Last year's edition of the "Children's Holiday Smile" campaign began on the last weekend of November and lasted until the end of 2024. The funds collected were transferred to: Good Samaritan Hospice in Lublin, Salvatorian Hospice Association in Bielsko-Biala, Help Them - Hospice for Children in Sochonie and the New York Children's Smile Foundation.

From the first day of the campaign, balances in four independent accounts increased at an extremely fast pace. Our members visiting their nearest branches made generous donations. Many of you made visits to your branch precisely to make the traditional do-

nations to the hospice accounts. It is worth remembering that all donations are tax deductible. We sincerely thank you for your donations, they were fully transferred to the organizations in the following amounts:

- Good Samaritan Hospice in Lublin
 \$53.469.13
- Salvatorian Hospice Association in Bielsko-Biala \$49,582.10
- Help Them Hospice for Children in Sochonie \$44,255.53
- Children's Smile Foundation in New York - \$22,005.32

The total amount donated this past December is \$169,312.08.

The "Children's Holiday Smile" charity fundraiser is an example of how solidarity, commitment and nobility of good people is universal, priceless and important above everything else. Your help reaching the sick young patients in hospices makes this last part of their road less painful and more dignified.

The help also applies to employees and volunteers in hospices, who can plan their work without stress and worry, and can focus their efforts on those in need, leaving the fundraising efforts and pending projects to be completed. Aleksandra Bieniek-Kuwik – PSFCU branch manager in Glendale Heights, IL
