Polish & Slavic Federal Credit Union participates in many important events in the lives of our members. Very often, we help them



buy their first car, first home or get their first credit card. We offer a whole range of financial services to our members, being the first financial institution used by Polish children and youth. At the same time, we take an active part in the life of the Polish community in the United States. In the past weeks, we participated in ceremonies commemorating Poles murdered 85 years ago by the NKVD in Katyn. With a memorial roll call and the laying of flowers, we commemorated the victims of this crime at the Katyn Memorial in Jersey City, NJ and at St. Adalbert's Cemetery in Niles, IL. We also paid tribute to the victims of the Smolensk disaster at the Shrine of Our Lady of Czestochowa in Doylestown, PA.

In addition to our efforts to nurture the commemoration of our history, the mission of the Polish & Slavic Federal Credit Union is to actively participate in educational, cultural and social events that strengthen Polish identity in America. Last fiscal year alone, we allo-

## We Remember Our Heroes

In April, the Polish community in the United States once again gave expression to its memory, unity and commitment to the national history. In three places - at the Katyn Memorial in Jersey City, NJ, at St. Adalbert's Cemetery in Niles, IL, and at the Shrine of Our Lady of Czestochowa in Doylestown, PA - ceremonies were held to commemorate two tragic events in modern Polish history: the 85th anniversary of the Katyn Forest massacre and the 15th anniversary of the Smolensk Disaster. Each of these events brought together representatives of local authorities and the Polish-American community. The anniversary celebrations were attended by representatives of Polish organizations, schools, scouts and clergy.

The Katyn Forest Massacre, carried out in the spring of 1940 by the Soviet NKVD, ...continued on page 2

A Varsovian by birth, a New York resident by choice, Hanna Olszowska has been with our Credit Union since the beginning of her career in the Unitclaimed the lives of more than 22,000 Polish officers and representatives of the civilian elite. The truth about Katyn was covered up for decades, and its disclosure became a symbol of the struggle for memory, justice and national identity. The Smolensk Disaster of April 10, 2010, in which 96 people have perished, including Polish President Lech Kaczynski and his wife, members of the government, the clergy and representatives of the Katyn families, has reconnected the fate of Katyn with the pain of modern generations of Poles.

For many years, the Polish & Slavic Federal Credit Union has actively participated in the commemoration of Poles who lost their lives as a result of these two events. This was also the case this year, and the presence of representatives of our Credit Union in Niles, Jersey City and Doylestown is an expression of solidarity with our compatriots in Poland and a deep need to cultivate the historical memory of our nation.


